AN ORDINANCE TO AMEND A PORTION OF THE
ORDINANCE ENACTED BY THE CITY OF NILES, MICHIGAN
AS ORDINANCE NO. 481

THE CITY OF NILES ORDAINS:

SECTION 1. PURPOSE AND INTENT

It is the purpose and intent of this Ordinance to amend a portion of the Ordinance enacted by the City of Niles, Michigan as Ordinance No. 481 by replacing the provisions of Section 3.C b. i and 3.C b. ii as contained in Ordinance No 481 with the provisions as set forth hereafter.

SECTION 2. AMENDMENTS

- A. Section 3.C b.i. of Ordinance enacted as Ordinance No. 481 shall be amended to read as follows:
 - i. Complete applications for a medical marihuana facility license determined to be in full compliance with the requirements of this Ordinance and as selected by the City through the Request For Proposal (RFP) process or any other process hereafter adopted by the City of Niles, shall be issued a provisional medical marihuana facility approval certificate in accordance with the procedures specified in this Section.

- B. Section 3.C b. ii. of Ordinance enacted as Ordinance No 481 shall be amended to read as follows:
 - ii. The City Clerk shall issue a provisional medical marihuana facility approval certificate to the person, persons or entity having their submitted RFP or other proposal accepted, and if the inspection, background checks, and all other information available to the City

verify that the applicant as a grower, processor, provisioning center, safety compliance facility, or secure transporter has submitted a full and complete application, has made improvements to the business location consistent with the application, complies with applicable zoning and location requirements, and is prepared to operate the business as set forth in the application, all in compliance with the City Code of Ordinances and any other applicable law, rule, or regulation.

SECTION 3. REVOCATION

As of the effective date of this Ordinance, Sections 3.C b.i. and 3.C b.ii as originally enacted in Ordinance No. 481 are revoked.

SECTION 4. REAFFIRMATION

Except as set forth herein, all other provisions of Ordinance No. 481 remains in full force and effect.

SECTION 5. EFFECTIVE DATE.

This Ordinance shall become effective twenty (20) days after its enactment.
