NOTICE OF PUBLIC HEARING
SUBSTANTIAL AMENDMENT TO THE PY 17 ANNUAL ACTION PLAN
COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

A public hearing will be held on February 26, 2018 at 5:55 p.m., at the City of Niles Fire Department in Council Chambers, 1345 E Main Street, Niles, MI, to obtain the views of citizens concerning the proposed substantial amendment to the City of Niles Community Development Block Grant 2017 Annual Action Plan.

The City of Niles receives CDBG funds for the purposes of undertaking a variety of projects meeting one of the three national objectives – 1) benefit low and moderate income persons, 2) aid in the prevention or elimination of slums and blight, or 3) meet other community development needs having a particular urgency. This year's funding was allocated as follows: Blight Elimination: \$100,000, Summer My Way: \$17,500, Chapin Mansion Porch Rehab: \$100,000, Project Administration: \$49,866, Homeless and Transportation Assistance: \$5,000, Code Enforcement: \$75,000, School Resource Officer: \$17,399. This request for substantial amendment proposes to add the Niles District Library Roof: \$75,000 and increase funding for the Chapin Mansion Porch Rehab to \$115,000.

The City's CDBG Citizen Participation Plan requires that the City will publish a public notice in a local newspaper which provides general circulation, announcing the availability of the Consolidated Plan or the Annual Action Plan and establishing a 15 day public comment period. The Public Comment Period Begins on the date of this publication and will extend until March 6, 2018 at 5:00pm EST. The City Council will consider the request for substantial amendment on Monday, March 12, 2018 at 6:00pm EST during the regular City Council meeting.

An electronic version of the 2017 Annual Action Plan including substantial amendment may be viewed on the City's homepage at www.ci.niles.mi.us or a hard copy may be viewed at the first floor of City Hall, 333 N. 2nd Street, Niles, MI or the Niles District Library, 620 E. Main St, Niles, MI.

If you are unable to attend the hearing, you may send a letter stating your opinions or position to the City of Niles (Attn.
